


Accordingly to this the product is exposed to the pressure of the potting material with the effect that the core, wire and termination is possibly damaged by this pressure and so the electrical as well as the mechanical characteristics are endanger to be affected. After the potting material is cured, the core, wire and termination of the product have to be checked if any reduced electrical or mechanical functions or destructions have occurred.

Cleaning agents that are used to clean application might damage or change the characteristics of the component, body, pins or termination.

- •Violation of the technical product specifications such as exceeding the nominal rated current will result in the loss of warranty.
