

#### 2. Features

- (1) Chip design of 3rd generation (Built-in SiC schottky barrier diode)
- (2) Low diode forward voltage:  $V_{DSF} = -1.35 \text{ V (typ.)}$
- (3) High voltage:  $V_{DSS} = 1200 \text{ V}$
- (4) Low drain-source on-resistance:  $R_{DS(ON)} = 60 \text{ m}\Omega$  (typ.)
- (5) Less susceptible to malfunction due to high threshold voltage:  $V_{th}$  = 3.0 to 5.0 V ( $V_{DS}$  = 10 V,  $I_D$  = 4.2 mA)




Fig. 6.2.1 Switching Time Test Circuit




Fig. 7.1 Marking




Fig. 8.1 I<sub>D</sub> - V<sub>DS</sub>




Fig. 8.3 I<sub>D</sub> - V<sub>GS</sub>




Fig. 8.5 R<sub>DS(ON)</sub> - I<sub>D</sub>




Fig. 8.2 I<sub>D</sub> - V<sub>DS</sub>




Fig. 8.4 V<sub>th</sub> - T<sub>a</sub>




Fig. 8.6 R<sub>DS(ON)</sub> - I<sub>D</sub>






Fig. 8.7 R<sub>DS(ON)</sub> - T<sub>a</sub>




Fig. 8.9 IDR - VDS




Fig. 8.11 V<sub>DSS</sub> - T<sub>a</sub>




Fig. 8.8 R<sub>DS(ON)</sub> - V<sub>GS</sub>




Fig. 8.10 I<sub>DR</sub> - V<sub>DS</sub>





Fig. 8.12 Dynamic Input Characteristics








Fig. 8.13 C - V<sub>DS</sub>

Fig. 8.14 Eoss - VDS





Fig. 8.15  $r_{th(ch-c)} - t_w$  (Guaranteed Maximum)






Fig. 8.16 Safe Operating Area (Guaranteed Maximum)

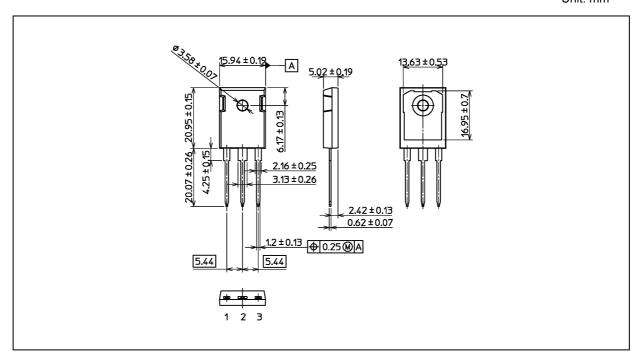
Fig. 8.17 P<sub>D</sub> - T<sub>c</sub> (Guaranteed Maximum)
