DESCRIPTION OF CHANGE: Add VISHAY Israel (Dimona) manufacturing facility as additional approved source for ST/STE product manufacturing.

REASON FOR CHANGE: WET tantalum products (135D, M39006/22, M399006/25, 136D, M39006/30 and M39006/31) are manufactured in both Ta capacitors plant in USA (Tansitor, Bennington) and in Israel (Dimona). In accordance with VISHAY contingency planning policy, it has been decided to qualify Dimona plant for ST/STE, WET tantalum capacitors also.
