





# Recommended Hole Pattern: [mm]

## Soldering:

- The solder profile must comply with the technical product specifications. All other profiles will void the warranty.
- · All other soldering methods are at the customers' own risk.

#### **Cleaning and Washing:**

Washing agents used during the production to clean the customer application might damage or change the characteristics of the
coating insulation, marking or plating. Washing agents may have a negative effect on the long-term functionality of the product.

#### Pottina:

If the product is potted in the customer application, the potting material might shrink or expand during and after hardening. Shrinking

- The storage conditions stated in the original packaging apply to the storage time and not to the transportation time of the components.


## Packaging:
