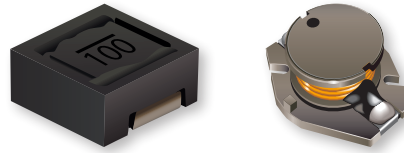

### Manufacturing Site and Process Changes

Riverside, California - February 13, 2024 – In order to support our fast-growing demand and enhance continuity of supply, effective July 1, 2024, Bourns will change manufacturing sites for select inductors to facilities with higher production capacity, and add additional manufacturing sites for other inductors. Additionally, for some of the affected part numbers, the marking, testing and taping processes, which were a mix of semi-automatic and automatic processes, will be integrated into one automated line. Lists of affected part numbers, organized by type of change, is included below.

There will be no product design or material changes as a result of the above changes. The inductors produced at the new/additional manufacturing sites will meet the same data sheet specifications as the inductors from the existing site.

The form, fit, function, quality, reliability, and country of origin of the affected part numbers will remain the same. Traceability will be maintained through lot code and date code.

Samples are available upon request. Bourns recommends that customers test the affected part numbers in their specific applications for verification of satisfactory performance.

#### Implementation dates are as follows:

Date that products manufactured at the existing location will cease: **June 30, 2024**

Date that deliveries of products manufactured at the relocated manufacturing sites will begin: **July 01, 2024**

First date code using the above changes: **2427**
