 - c) In a place exposed directly to sun light or headlight of automobile.
 - d) In a place exposed directly to blow from air-conditioner or heater.
 - e) In such a place where infrared ray is shaded.
 - f) In any other place similar to the above (a) through (e).

9-2 Notice in handling and storage

- 1) Strong shock should be avoided.
- 2) High temperature, high humidity, fluid as water or alcohol etc., corrosive gas (S0₂, Cl₂, and NOX etc.) and sea breeze should be avoided.




Figure 1 Outline Drawing and Dimensions








Figure 2. A board hole for hook insert
