#### **USES**

Bostik White Glu is a water-borne adhesive based on vinyl acetate homo-polymer & polyvinyl alcohol, supplied in an easy to use plastic bottle. Bostik White Glu has been designed to meet the stringent EC child safety legislation.

A general purpose, solvent free glue for arts and crafts, sticking paper and card. Ideal mixed with powder paints for finger painting and watering down to make paper maché.

#### **PREPARATION**

- 1. Always open and use adhesive products over a protected work surface.
- Ensure the surfaces to which Bostik White Glu is to be applied are clean and dry.

# **APPLICATION**

- Hold the coloured part of the nozzle and gently twist anti - clockwise.
- Squeeze the bottle gently and apply to one or both surfaces.
- 5. For non-porous surfaces, allow glue to become tacky to the touch before bringing the surfaces together.
- 6. Wipe nozzle after use, then twist nozzle clockwise to close to prevent the glue from becoming unusable.

# **CLEANING**

- 7. Any excess glue may be removed by using a damp cloth.
- 8. May be washed out of clothes using warm soapy water, ideally before glue is dry.
