





Gate-Current vs. Gate-Source Voltage




Gate-Current vs. Gate-Source Voltage









On-Resistance vs. Drain Current and Gate Voltage













On-Resistance vs. Junction Temperature






Source-Drain Diode Forward Voltage









Single Pulse Power, Junction-to-Ambient






Safe Operating Area, Junction-to-Ambient



Normalized Thermal Transient Impedance, Junction-to-Ambient (on 1" x 1" FR4 board with maximum copper)





