2.1. Classification of the substance or mixture

4.1. Description of first aid measures

Skin contact: May cause irritation on prolonged or repeated contact.

Eye contact: Irritation with short term redness and stinging.

Ingestion: May cause nausea and diarrhoea.

Inhalation: May cause irritation of the respiratory tract.

Section 5: Fire-fighting measures

5.1. Extinguishing media

Extinguishing media: Carbon dioxide (CO2). Dry chemical powder. Alcohol resistant foam. Sand or earth. Do

5.2. Special hazards arising from the substance or mixture

Exposure hazards: In a fire, hazardous decompostition products such as smoke and Carbon Monoxide may be produced.

5.3. Advice for fire-fighters

Advice for fire-fighters: Exposure to decomposition products may be a hazard to health. Appropriate self-

contained breathing apparatus may be required. Cool closed containers exposed to fire with water spray. Do NOT allow run-off from fire fighting to enter drains or water courses.

Section 6: Accidental release measures

6.1. Personal precautions, protective equipment and emergency procedures

Personal precautions: Ventilate the area. Eliminate all sources of ignition. No Smoking. Avoid inhaling vapour.

Mark out the contaminated area with signs and prevent access to unauthorised personnel. Do not attempt to take action without suitable protective clothing (see section

sunlight. Exclude sources of heat, sparks and open flame. Take precautionary
