<b>Reason for Change:</b>	<p>Embossing tape material is changed for improvement of strength and heat resistance. As a countermeasure against the thermal deformation of the embossed tape during transportation, the material is changed from A-PET to PS with high heat resistance and Cover tape material will be changed to Halogen free material as similar timing. This changes will be made as soon as possible, but since there are many intended products, changes will be made with running changes.                      It makes compliant with the latest JIS/IEC requirement. The actual specification is already meet JIS/IEC.</p>
