Product specific:

Cleaning and Washing:



Packaging:

Handling:

- Use a M4 screw to mount the Earthing Metal Clip to the PCB.
- The Earthing Metal Clip shall not exceed the recommended clamping torque. If the recommended clamping torque is exceeded, there is a risk that the Clip will not be able to push back into the initial state.
- Do not bend the Metal Clip to the opposite position, as the material will overstretch and possibly break.
- Avoid connecting, touching, or overlapping the contact between the cable and PCB with any non-conductive coating.


