



COLLECTOR TO EMITTER VOLTAGE :  $V_{CE}$  [V]


Fig.3 DC Current Gain vs. Collector Current (I)






#### Fig.4 DC Current Gain vs. Collector Current (II)




#### ●Electrical characteristic curves(T<sub>a</sub> = 25°C)



# Fig.7 Base-Emitter Saturation Voltage vs. Collector Current




#### Fig.8 Gain Bandwidth Product vs. Emitter Current







#### Fig.9 Capacitance vs. Reverse Bias Voltage





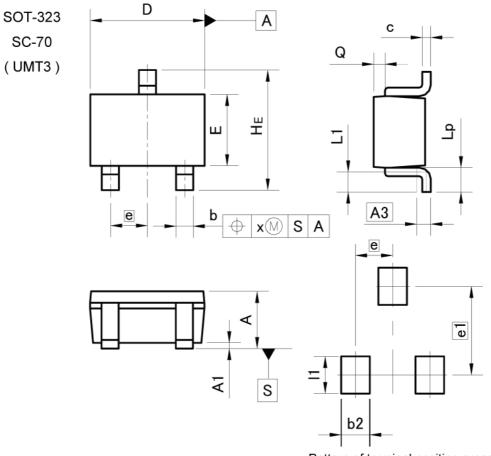
# Fig.11 Noise factor vs.collector current characteristics
