Overview Description of Change

- Powersonic, a Molex Tier-I supplier, has been identified as a high-risk supplier partner due to weakening health of their business. To ensure business continuity and protect our customer base Molex had to make the decision to terminate our business relationship with Powersonic and transfer all tools to Phillips Medisize (a Molex owned entity)
- Molex needs to coordinate immediate transfer of the 19 molds currently housed at Powersonic to Philips Medisize. Both facilities are within the Juarez region of Mexico
- All tooling currently located at Powersonic is Molex owned, therefore considered catalog/general market product
- There is no impact to product Fit, Form or Function with these transfers.
- Product validation plans will be approved by the OEMs
- Start of Production is forecasted/targeted to begin in September 2022
