

DESCRIPTION

The VLWTG9600 is a clear, non diffused LED for applications where supreme luminous flux is required. It is designed in an industry standard 7.62 mm square package utilizing highly developed InGaN technology. The supreme heat dissipation of VLWTG9600 allows applications at high ambient temperatures.

All packing units are binned for luminous flux, forward voltage and color to achieve the most homogenous light appearance in application.




Figure 1. Forward Current vs. Ambient Temperature for InGaN




Figure 2. Forward Current vs. Pulse Length




Figure 3. Rel. Luminous Intensity vs. Angular Displacement




Figure 4. Percentage Total Luminous Flux vs. Total Included Angle for 90 ° emission angle




Figure 5. Thermal Resistance Junction Ambient vs. Cathode Padsize




Figure 6. Forward Current vs. Forward Voltage




Figure 7. Rel. Luminous Flux vs. Ambient Temperature




Figure 8. Specific Luminous Flux vs. Forward Current




Figure 9. Relative Luminous Flux vs. Forward Current




Figure 10. Relative Intensity vs. Wavelength





Figure 11. Dominant Wavelength vs. Forward Current












