'To sustain supply of parts listed on following PN tab, Electro switch needs to temporarily change the silver plating used on the terminals to Gold/Nickel/Silver (letter code G)

Per part specification, standard construction for letter code Q for Contact material indicates Coin Silver. Ref: https://www.electro-nc.com/sites/electro-nc/files/tog_a.pdf This material substitution from silver to gold terminal plating is considered an upgrade, and is being offered temporarily at no change to your PO pricing. This material substitution does not impact switch form/fit/function. Please notify your Incoming Inspection/Quality Assurance team because the temporary change from Silver (Q) to Gold (G) will be visible on the terminals. There will be no change to the part number labeling.

Reason for the Change
