



Relative Intensity Vs. Wavelength



Reflow Soldering Profile For Lead-free SMT Process.





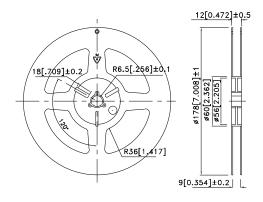


## **Recommended Soldering Pattern** (Units: mm; Tolerance: ± 0.1)


