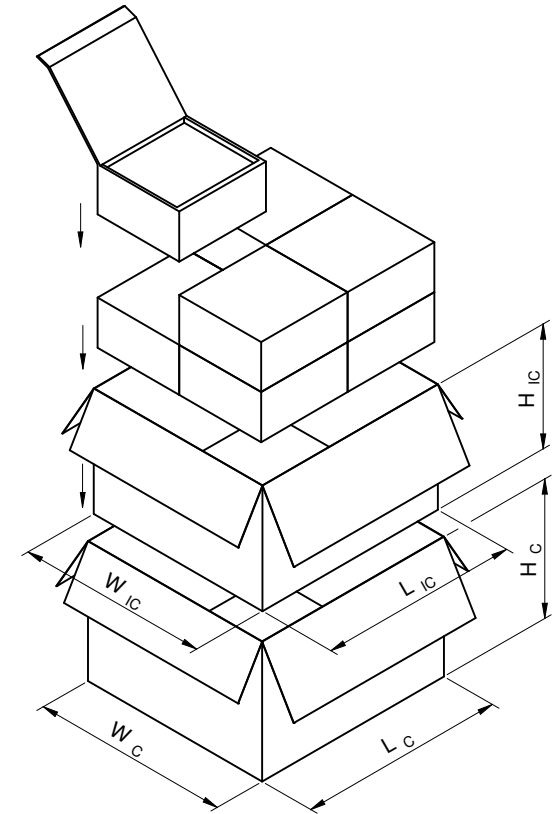
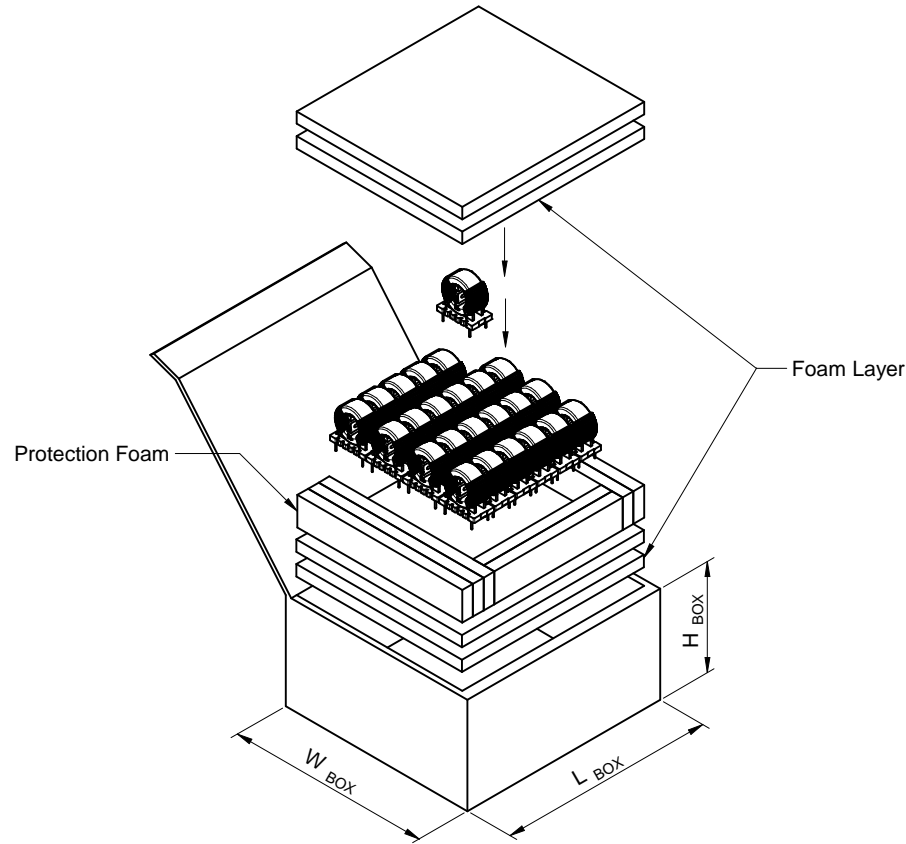


Derating Curve:

Soldering




