Overview

- 212725 series (Micro-One 2.0 W/B TPA Retainer) changes resin due to resin supplier's supply constraints.
- Product Impact
 - Product color will change from gray color to natural color. → Molex's Sales Drawing document number 2127250000-SD will be updated from rev B → rev C to include these changes.
 - No impact to fit, form (except color above) or function.
 - The after-change product will be low halogen compliant. →
 - The bubble wrap used for packaging will change (quantity of products in a carton and bags will remain unchanged).
- Part Number Impact
 - 2127252020, 2127252030, 2127252040, 2127252050, 2127252060, 2127252070, 2127252080 (remain same part number)

- Implementation: Cut-in starting from 01-Jan-2024 manufacturing date, i.e. date code 24** or traceability code 4***** and above. Example beside for a packing label from year 2023 manufacturing date, will contain gray color samples before the cut-in:
