

KleenGuard ® A71 Chemical Permeation & Jet Liquid Protection Coveralls; Hooded coveralls, front fastening with velcro secured stormflap, constructed from two layer Film/Spunbond laminated yellow fabric, with sewn and sealed taped seams & elastication at cuffs, hood ankles and waist. Available in five nominal sizes. Product codes 9676000 – 968000 (inclusive).

It is certified that the manufacturer's technical file and the above mentioned PPE have been assessed and found to be in accordance with the requirements of Council Directive 89/686/EEC. When examined the PPE satisfied the relevant requirements of the harmonized standards, EN 1073-2:2002 (non-ventilated protective clothing against particulate radioactive contamination) for a performance classification of TIL Class 1; EN ISO 13982-1:2004 (Type 5 Limited life, full body chemical protective clothing against solid particulates); EN14605:2005 (Type 3 & 4 limited life, full body chemical protective clothing with liquid tight connections) & EN14126:2003 (Type 3-B,4-B & 5-B Limited life, full body protective clothing against infective agents.

In addition the fabric met the requirements of EN 1149-1:1995 for electrostatic dissipative protective clothing on the spunbond inner surface.

The manufacturer's information notice (detailed in Technical File Kleenguard A71) in English has been inspected and found to have addressed all of the relevant requirements of the standards. However, the detailed content of the information notice is the responsibility of the manufacturer, as are translations into other languages.

This certificate is issued on the strict condition that appropriate checks on manufactured PPE, as detailed in Article 11 of the Directive are implemented and maintained while the model is in production.
