



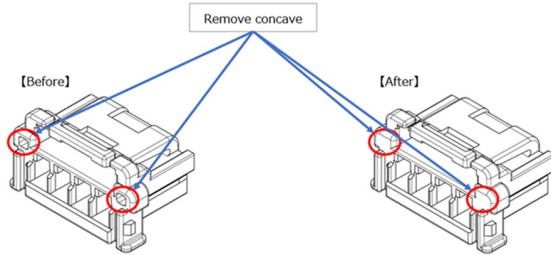

 - Remove the concave and then return to the original size of the air venting
- Reason:
 - To reduce quality risks of Bubble & Gate flash
- Product Impact
 - Impact to cosmetic appearance. But there is no change of Fit or Function.
