Do not spray on an open flame or other ignition source. Do not pierce or burn, even after use. Spray will evaporate and cool rapidly and may cause frostbite or cold burns if in contact with skin. Do not expose to temperatures exceeding 50°C/122°F. Avoid inhalation of vapours and spray/mists. Avoid contact with eyes.
<b>Advice on general occupational hygiene</b>	Good personal hygiene procedures should be implemented. Wash contaminated skin thoroughly after handling.
