Description of Changes: with diagrams if relevant

1. Increase reel quantity from 270pcs per reel, 2700pcs per carton (revision A) to 450pcs per reel, 4500pcs per carton (revision B)
2. Change reel dimension form 330mm to 380mm diameter.
3. Change carton dimension from 340mm x 340mm x 320mm to 400mm x 400mm x 320mm

Reason for Change:

More Product can be loaded on a reel. This lowers the changeover time on SMT production lines.

Anticipated Impact on Form, Fit, Function, Reliability or Revision to Material Declaration:

Product remains unchanged. Warehouse provisioning & production line may require adaptation to accommodate the larger 400mm square boxes and 380mm diameter reels.

Details of Ongoing Availability of Existing Version of Product:

270 pieces per reel will no longer be available when existing stocks have been exhausted.

Details of Availability of Samples of Revised Product and Supporting Documentation:

Drawings have been revised to show new packing. Product remains unchanged.

Required Inventory Action:

Run out stocks of 270 pieces per reel.
Final batch number value for revision A stock is 201106-001
