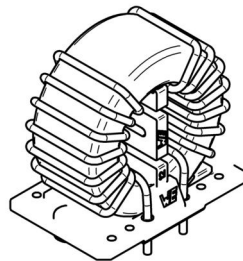

**C Schematic:**



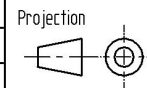
