


Relative Spectral Sensitivity 1), 2)





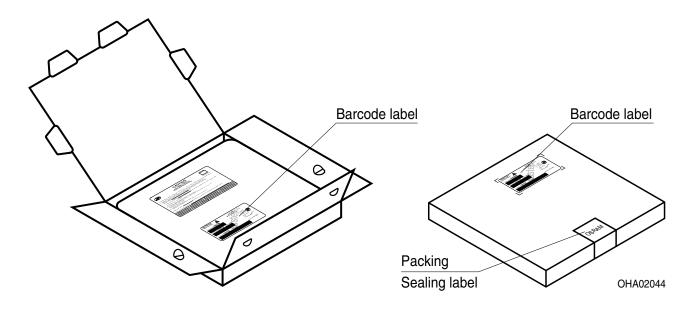
