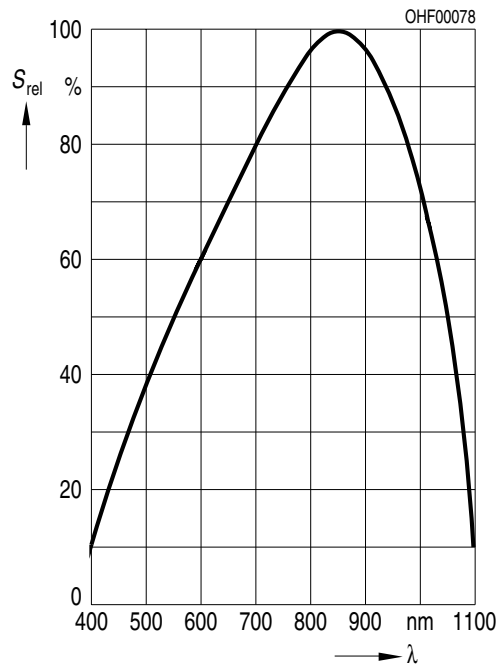

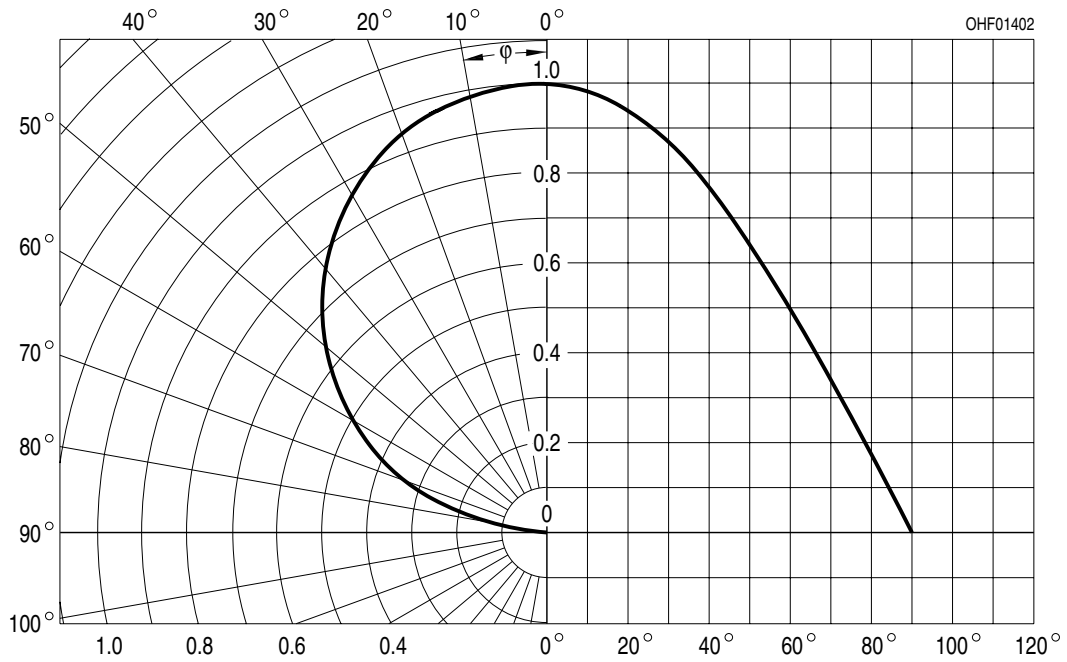

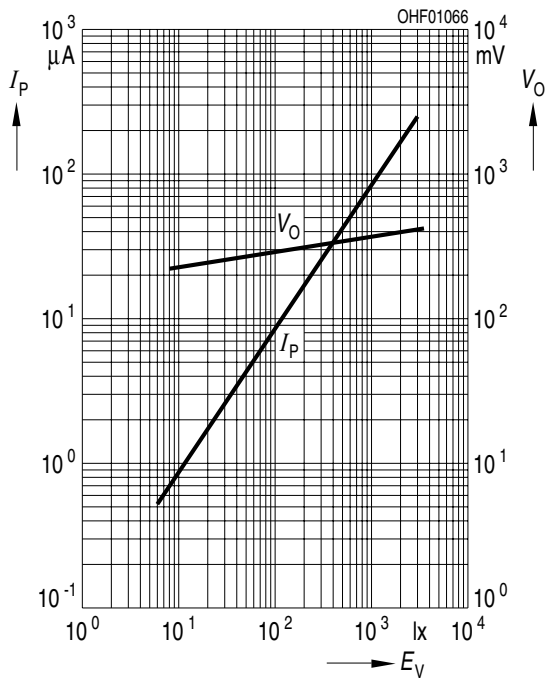
## Directional Characteristics <sup>1), 2)</sup>

$$S_{rel} = f(\varphi)$$



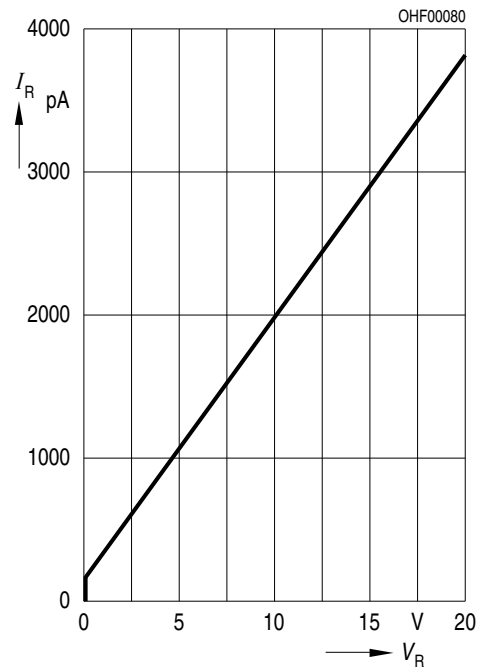

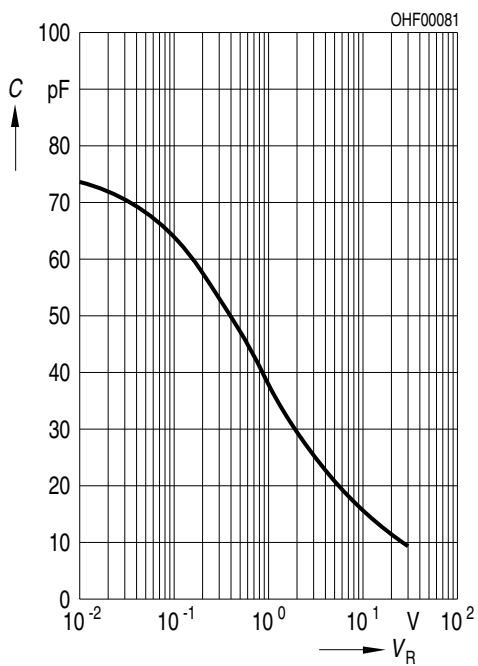
**Dark Current** <sup>1), 2)</sup>

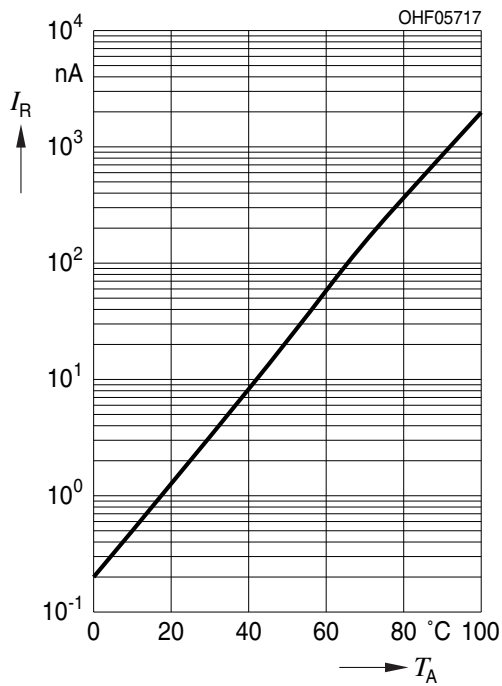

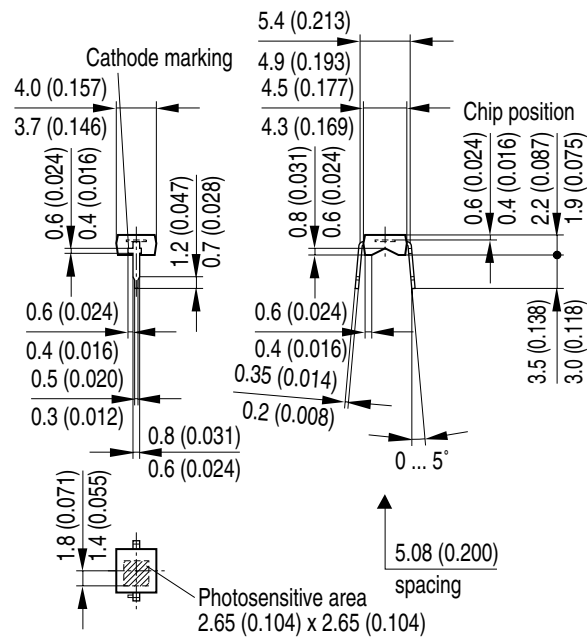


## Power Consumption

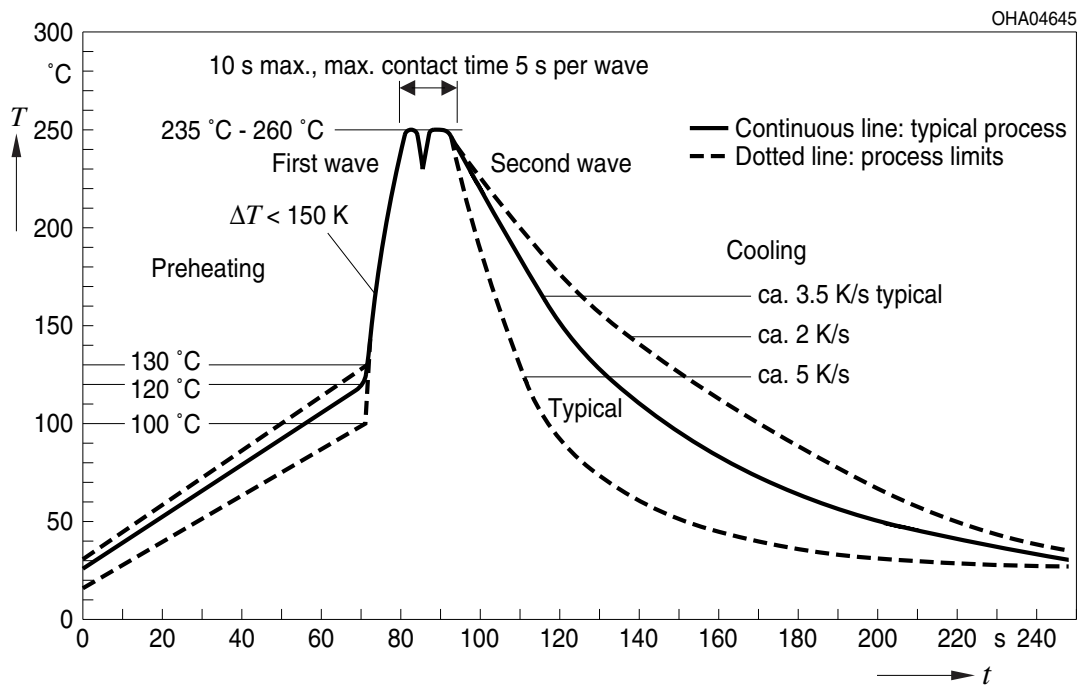

## Notes
