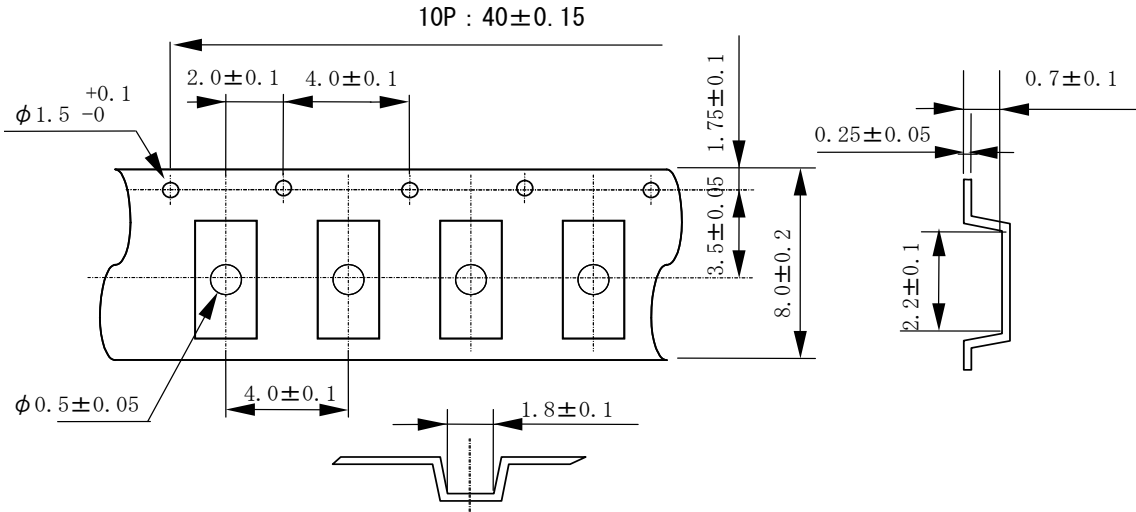

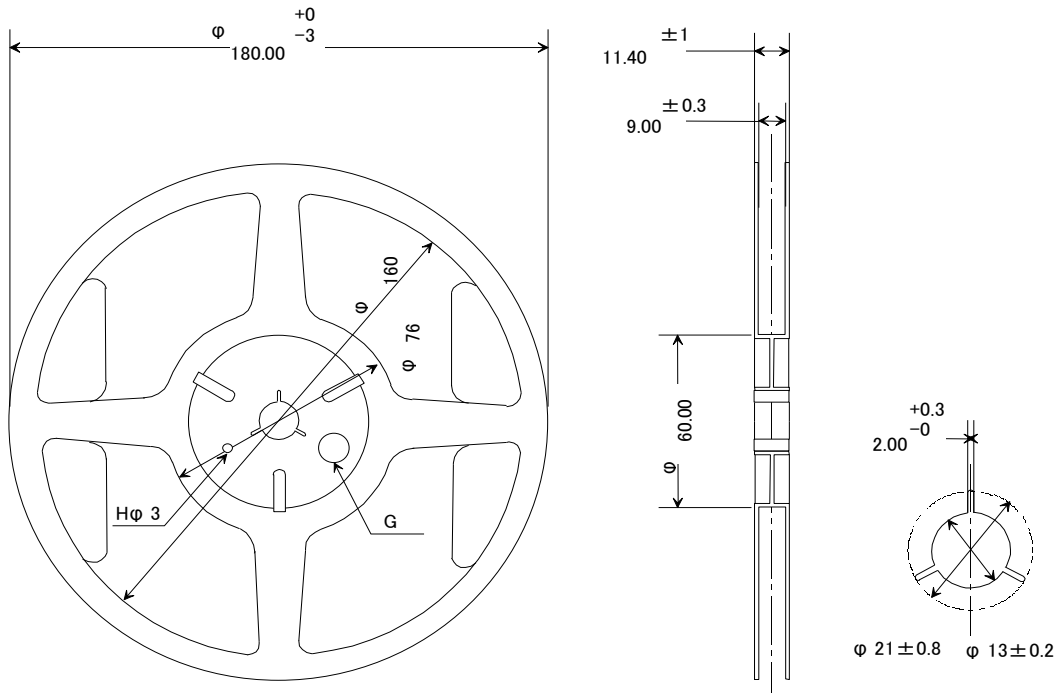


(2) Reel dimensions

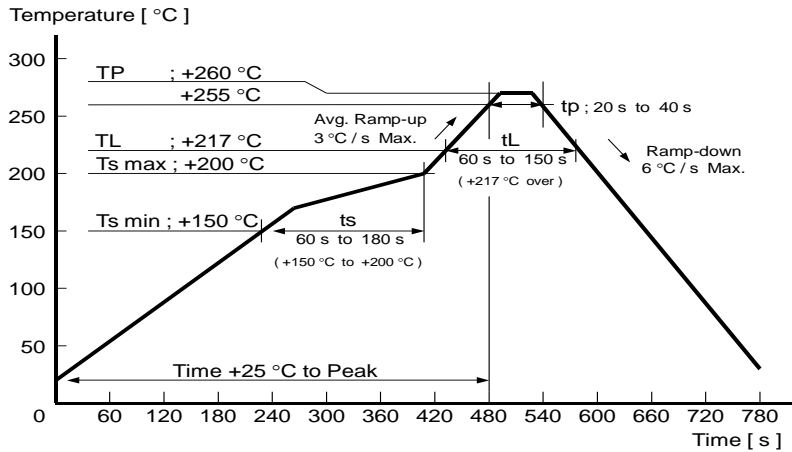
