



#### General:

- Würth Elektronik must be asked for written approval (following the PPAP procedure) before incorporating the components into any

## **Product specific:**

## **Cleaning and Washing:**

 Washing agents used during the production to clean the customer application might damage or change the characteristics of the component. Washing agents may have a negative effect on the long-term functionality of the product.

## Potting:

If the product is potted in the customer application, the potting material might shrink or expand during and after hardening. Shrinking
could lead to an incomplete seal, allowing contaminants into the core. Expansion could damage the core. We recommend a manual
inspection after potting to avoid these effects.

#### Winding:

The caused pressure by winding of the product could damage the product as well as negatively influence the magnetic characteristics.

## **Storage Conditions:**

- A storage of Würth Elektronik products for longer than 12 months is not recommended. The material characteristics of the components
  form a limiting factor for the storage stability. Therefore, all products shall be used within the period of 12 months based on the day of
  shipment.
- Do not expose the components to direct sunlight.
- The storage conditions in the original packaging are defined according to DIN EN 61760-2.
- The storage conditions stated in the original packaging apply to the storage time and not to the transportation time of the components.


### Packaging:

 The packaging specifications apply only to purchase orders comprising whole packaging units. If the ordered quantity exceeds or is lower than the specified packaging unit, packaging in accordance with the packaging specifications cannot be ensured.

### **Handling:**

- Violation of the technical product specifications such as exceeding the maximum outer diameter of the cable will void the warranty.
- The usage in an acid as well as salty environment can be the reason for oxide (rust) on the surface of the nanocrystalline body, damage
  or changes of the material characteristics. The acid or salty environment may have a negative effect on the long-term function of the
  product
- If a component drops, it has to be sorted out as it might change its magnetic characteristics.
- Avoid touching damaged components.
- The temperature rise of the component must be taken into consideration. The operating temperature is comprised of ambient temperature and temperature rise of the component. The operating temperature of the component shall not exceed the maximum or minimum temperature specified.
