# **Typical Temperature Rise vs. Current Characteristics:**





# **Typical Inductance vs. Current Characteristics:**






# **Typical Impedance Characteristics:**








### Potting:

- The storage conditions stated in the original packaging apply to the storage time and not to the transportation time of the components.


### **Packaging:**
