# Introduction of new carrier tape material

#### **Notification information**

A new surface material for carrier tapes for the packages DFN1010D-3 (SOT1215), DFN1010B-6 (SOT1216), DFN2020-3 (SOT1061), DFN2020D-3 (SOT1061D), DFN2020-6 (SOT1118), DFN2020D-6 (SOT1118D), DFN2020MD-6 (SOT1220) and DFN2020M-6 (SOT1220-2) will be introduced as second source: Polycarbonate (PC) instead of Polystyrene (PS). The core material of the carrier tape (Acrylonitrile butadiene styrene, ABS) as well as the cover tape material will remain unchanged.

The surface material does not impact the handling of the carrier tape nor the peel off force/behavior of the cover tape. The pick and place behavior will not change. The visual appearance, dimension and electrical performance of the packed devices are not influenced by this change. For details please refer to attached information package.
