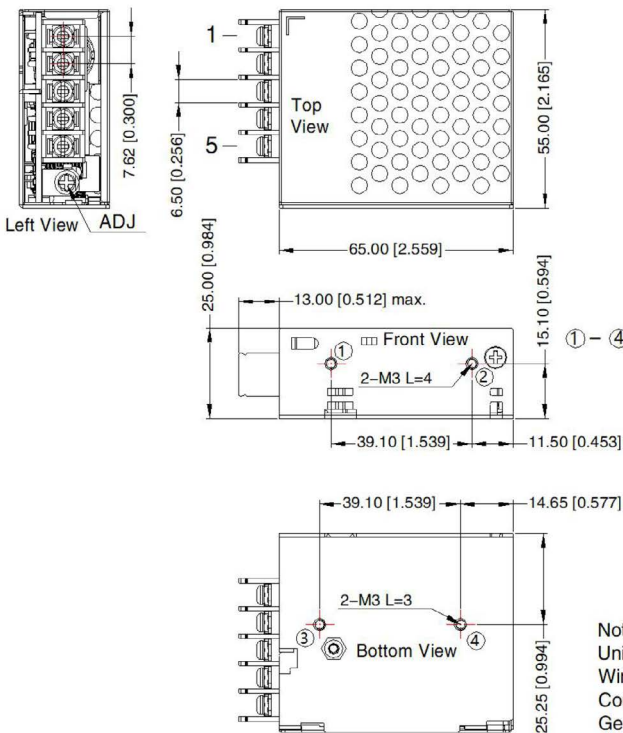
Product Characteristic Curve

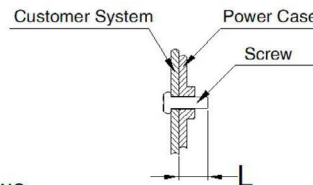
