### Typical Inductance vs. Frequency Characteristics:



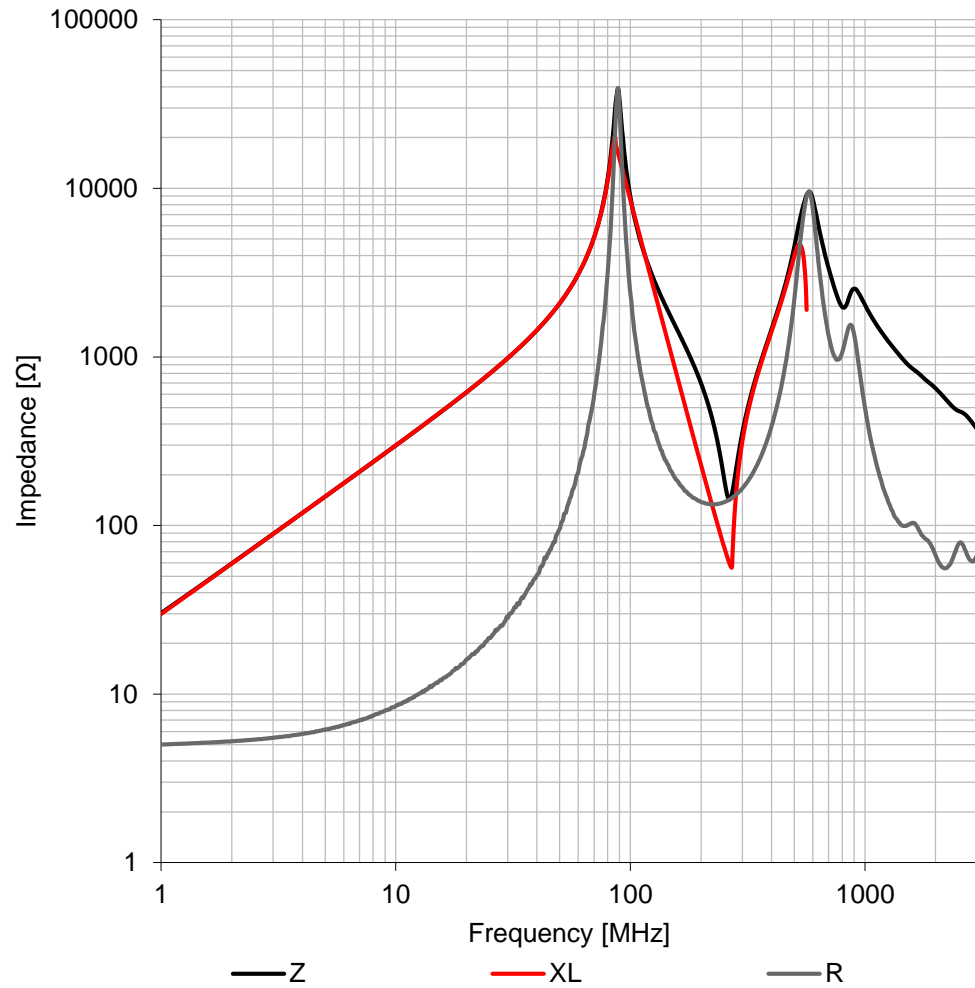

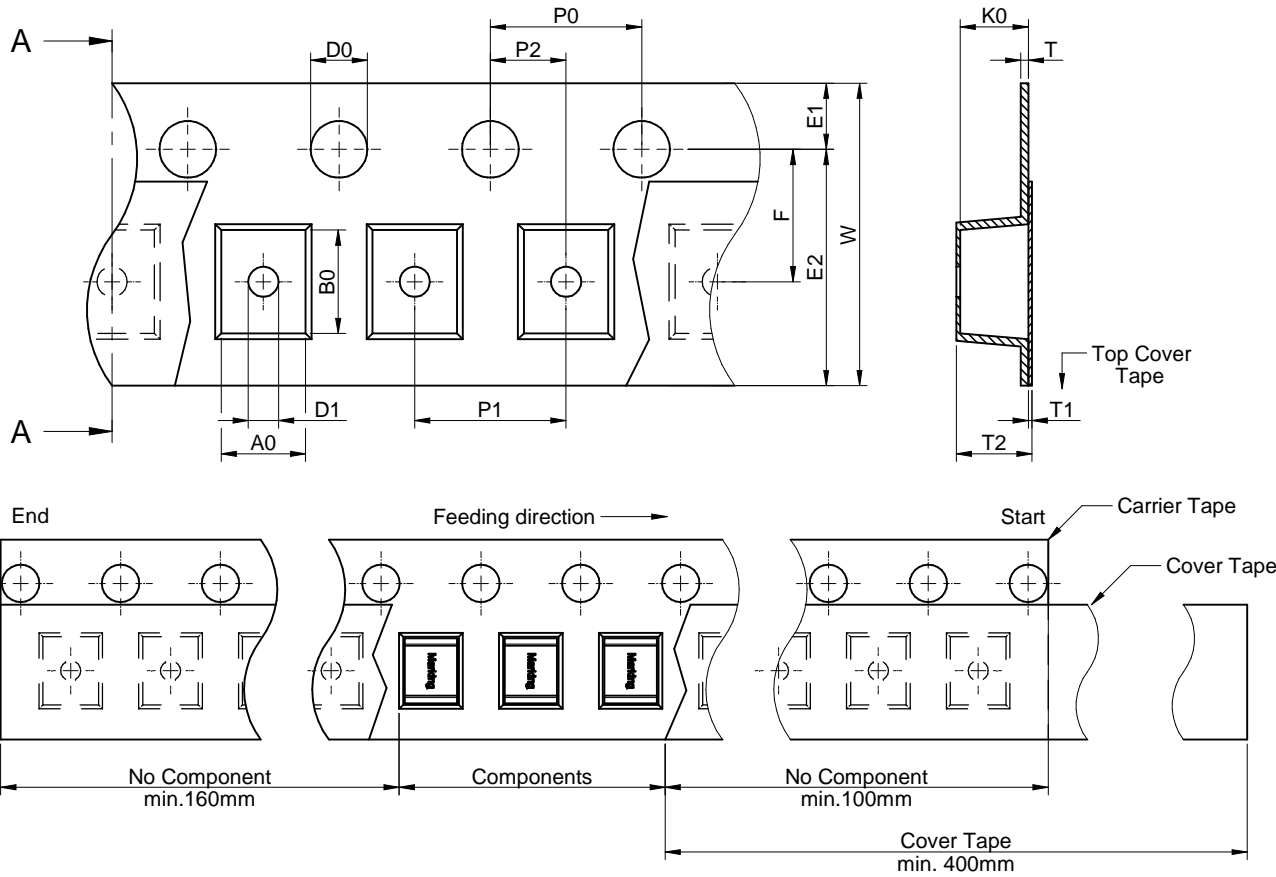
# Typical Impedance vs. Frequency Characteristics

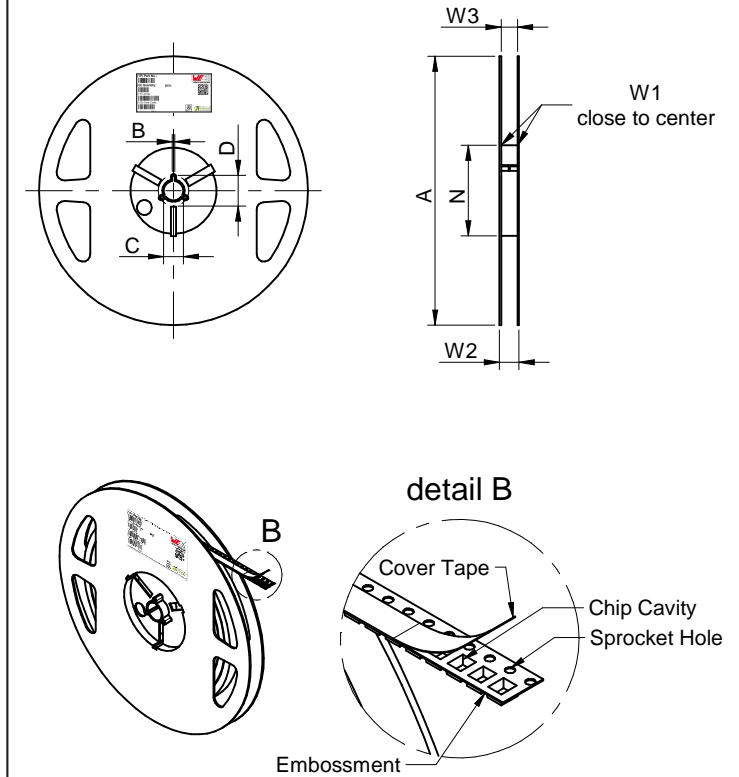

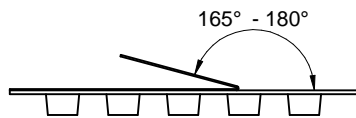

#### Soldering:



#### Storage Conditions:


