2. Background/Request:

These series are produced by our company, Anamizu Murata Manufacturing Co., Ltd. (Anamizu Factory).
The Anamizu factory was affected by the 2024 Noto Peninsula earthquake that occurred on January 1, 2024.
At the present time, production has been suspended, but we are working on the recovery and earliest schedule will be after May.
However, due to the effects of the earthquake, it is difficult to secure the same number of operators as before the earthquake, thus it is practically difficult to resume production of all series at the Anamizu factory.
Therefore, we will prioritize supply to our customers and begin alternative production at our Malaysia factory(*1).
Currently, the Malaysia factory(*1) is in the progress of establishing a process control system at the same level as Anamizu factory.
