Cypress announces the qualification of Cypress Bangkok (229 Moo 4 Changwattana Road, Pakkret, Nonthaburi 11120, Thailand) as an additional assembly site for select 48-Lead TSOP I, 18.4x12x1.2mm, Pb-Free products.

The 48-Lead TSOP I, 18.4x12x1.2mm Pb-Free package are assembled at Cypress Bangkok using the following Bill of Materials:

Approximate Implementation Date:

Effective 90 days from the date of this notification or upon customer approval, whichever comes first, all shipments of Commercial, Industrial and Automotive non-PPAP part numbers in the attached file will be assembled at Cypress Bangkok or other approved assembly sites.

For Automotive PPAP part numbers this change will be effective upon customer approval.

Anticipated Impact:

Products assembled at the new site are completely compatible with existing products from form, fit, functional, parametric and quality performance perspectives.

Cypress also recommends that customers take this opportunity to review these changes against current application notes, system design considerations and customer environment conditions to assess impact (if any) to their application.

Method of Identification:

Cypress maintains traceability of product to wafer level, including wafer fabrication location, through the lot number marked on the package.
