Description

G-WIPES are wet wipes for cleaning heavy soiling without using water. G-WIPES wipes are made of polypropylene and impregnated with a cleaning solution. Each individual wipe allows regular cleaning without the use of additional abrasives due to its slightly rough structure. G-WIPES clean quickly and effectively without excessive skin damage.

Applications

For pre-cleaning or quick cleaning of heavy soiling such as mineral oils, graphite, metal dust, soot. For workplaces without water facilities. Ideal for lorry drivers, breakdown workers, assembly and maintenance staff, craftsmen, etc.

Precautions for use & storage

Qualitative composition*

Aqua, Trideceth-10, Dimethyl Glutarate, Trideceth-5, Propylene Glycol, Dimethyl Succinate, Cocamidopropyl Betaine, Dimethyl Adipate, Diazolidinyl Urea, Iodopropynyl Butylcarbamate, PEG-4, PEG-4 Dilaurate, PEG-4 Laurate, Parfum

* The terms used correspond to the international nomenclature for cosmetic ingredients (INCI = International Nomenclature Cosmetic Ingredients)

Skin compatibility

Tests and practice have shown that G-WIPES has good skin compatibility. A certificate of skin tolerance has been issued for G-WIPES by the Dermatology Department of the Krefeld Clinic.

Regulations

This cosmetic product is governed by EC Regulation 1223/2009 (as amended), and is therefore exempt from the creation of a Safety Data Sheet under EC Regulation 1907/2006 (as amended). It is also exempt from the labelling and classification and packaging rules of the CLP Regulation (EC) No 1272/2008.

Storage

G-WIPES wipes can be stored for at least 30 months at room temperature in its unopened packaging. Period of use after opening (POW): see indications on the packaging.

First aid measures

Inhalation	Not relevant. Unlikely route of exposure as the product does not contain volatile substances.
Ingestion	Rinse mouth thoroughly with water. Seek medical attention if discomfort persists.
Skin contact	Not relevant.
Eye contact	Remove contact lenses and open eyelids wide. Continue rinsing for at least 15 minutes. Seek prompt medical attention if symptoms develop after washing.
