DIN Socket Connector Assemblies, 1.5mm 5-7 Position and 2.5mm 2-4 Position

### Description of Changes

The Industrial and Commercial Transportation business unit of TE Connectivity is approving an alternate 2nd source material for the DIN Socket Connector assemblies with part number(s) listed below. The 2nd source is a PA66 GF30 similar to the current material used in production for the Coupling Ring component. These PNs are TE proprietary designs, therefore considered catalog/general market product. PPAP and/or sample requests must be submitted within 14 days of PCN submission via ict-ppap-request@te.com or ePPAP system. Submission will not occur without request. If PPAP is requested, a disposition response is required within 14 days of the submit date or it will be considered approved. Customer product drawing(s) are not affected by this change.

### Reason for Changes:

Due to the recent resin shortages due to force-majeure; we hereby inform you of our decision to use an alternate 2nd source PA66 GF30 material for the products mentioned within this notification. The alternate material being similar in type with the currently used in production does not impact fit, form and function and parts made of this material are interchangeable with the existing design assemblies. IMPORTANT: There is no part revision increase for this change at the sales assembly level.
