As an official partner of Wirepas™, Würth Elektronik is authorized to make commercial use of Wirepas firmware for the purposes of normal business.

### Soldering:

- The solder profile must comply with the technical product specifications. All other profiles will void the warranty.
- All other soldering methods are at the customer's own risk.

### Cleaning and Washing:

- Washing agents used during the production to clean the customer application might damage or change the characteristics of the component. Washing agents may have a negative effect on the long-term functionality of the product.

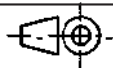
