KleenGuard A40 Liquid and Particle Protective Coveralls, constructed from a three layer Polypropylene F/S (Film / Spunbond) fabric 65 g/m<sup>2</sup> in white, with internally stitched seams & elastics at cuffs, hood, ankles and waist.

Available in six nominal sizes, with product codes 9790-9795 inclusive (global codes 49791 – 49795 inclusive).

It is certified that the manufacturer's technical file and the above mentioned PPE have been assessed and found to be in accordance with the requirements of Council Directive 89/686/EEC. When examined the PPE satisfied the relevant requirements of the harmonized standards:

EN 1073-2:2002 (non-ventilated protective clothing against particulate radioactive contamination) for a performance classification of TIL Class 1;

EN ISO 13982-1:2004 (Type 5 Limited life, full body chemical protective clothing against solid particulates);

EN13034:2005 (Type 6 Limited life, full body chemical protective clothing offering limited protective performance against liquid chemicals.

In addition the fabric met the requirements of EN 1149-1:1995 for electrostatic dissipative protective clothing on inner surface.
