Product Specific:

Cleaning and Washing:



Packaging:

Handling:

- The maximum permissible torques must be complied with to prevent mechanical destruction of the component and PCB.
- If a component is pre-assembled with an adhesive tape, the adhesive duration cannot be guaranteed. This depends on the surface where the component will be mounted on. 
